**RESOLUTION AUTHORIZING RELEASE OF PERFORMANCE
BONDS FOR THE VILLAGES AT ABERDEEN (SECTIONS 2.3) WATER
AND SEWER IMPROVEMENTS AND WAIVING THE POSTING OF A
MAINTENANCE BOND**

WHEREAS, the applicant, Hovbros Clayton, LLC, has posted, pursuant to the requirements of the Clayton Development Regulation and Zoning Ordinance, Performance Guarantees, guaranteeing the water & sewer improvements in conjunction with said project; and

WHEREAS, the said applicant has completed said improvements and has applied for a release of said performance guarantees; and

WHEREAS, the Borough Engineer has made an inspection and rendered a report, dated September 2, 2020, a copy of which is attached hereto, and made a part hereof, certifying that the water & sewer improvements have been completed; and

WHEREAS, the Borough Engineer has also recommended that the maintenance bond requirement be waived; and

WHEREAS, prior to release of said performance bond, all outstanding engineering, escrow and legal fees, if any, shall be paid in full.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey, that the aforementioned performance guarantees for Hovbros Clayton, LLC, be and hereby is released.

BE IT FURTHER RESOLVED that any and all outstanding engineering, escrow and/or legal fees, if any, shall be paid in full.





Dear Mayor and Council Members:

Pursuant to the request made by Applicant, via letter dated August 5th, 2020, we have completed our review of the above referenced site to determine if the reduced performance bond amount can be released for the above referenced residential development.

As such, this office has completed our construction observation of the water & sewer improvements for the purpose of determining if the performance bond (reduced amount) can be released in the amount of \$73,676.16. Based on the findings of our site observation, we are informing the Borough that the work under this project has been completed, corrected and/or repaired in accordance with the requirements of the Borough of Clayton. As such, we are acceptable to Council releasing of the performance bond.

Since the water & sewer improvements have been installed, tested, verified and in service for a period of over approximately 13 years, we are acceptable to the maintenance bond being waived for the water & sewer in this section. The water & sewer performance bond can be released along with the site performance bond for this section. We request that this matter be placed on the agenda for the next available Mayor and Council meeting.
