RESOLUTION CONFIRMING PRIVATE SALE OF VACANT LAND TO JOHN NEWSOME, ADJACENT PROPERTY OWNER, FOR BOROUGH OWNED VACANT LAND KNOWN AS BLOCK 1818, LOT 4 FOR THE TOTAL SUM OF \$500.01

 - 2. The property is sold in the existing as-is condition.
- 3. The property is sold under and subject to any and all municipal easements, if any.
- 4. The property is being sold subject to all existing Borough of Clayton Zoning and Land Use Laws.
 - 5. Settlement shall be completed within thirty (30) days of the award of the bid.
 - 6. The Borough shall convey ownership of the property by a Quit Claim Deed.

7. The successful bidder will be given the opportunity to purchase Title Insurance on the property at their sole cost. In the event the Borough cannot convey free and clear title, then this sale shall be declared null and void.
