**RESOLUTION AWARDING CONTRACT FOR THE ROADWAY

*WHEREAS*, GWP Enterprises, Inc., of Franklinville, New Jersey was the successful bidder complying with all bid requirements and specifications; and

*WHEREAS*, the Borough Engineer has rendered a report dated March 20, 2020, a copy of which is attached hereto, and made a part hereof, recommending the award of the bid to GWP Enterprises, Inc., in an amount not to exceed \$169,115.00; and

*WHEREAS*, Donna Nestore, CFO, for the Borough of Clayton certifies the above referenced dollar amount is available through the NJDOT 2019 Municipal Aid Program Grant; and

*NOW, THEREFORE, BE IT RESOLVED* by the Mayor and Council of the Borough of Clayton, that GWP Enterprises, Inc., be and hereby is awarded the Contract for the roadway improvements of Walnut Street in the amount of \$169,115.00 in accordance with and as more particularly described in the bid proposal submitted by said bidder and in accordance with the terms and conditions set forth in the specifications promulgated by the Borough of Clayton; and

*BE IT FURTHER RESOLVED* that the Mayor and Clerk be and hereby are authorized to execute said Contract.



On Thursday, March 19, 2020, at 11:00 A.M., sealed bids for the above referenced project were received and publicly opened at the Municipal Building by Olivier Peña of Sickels & Associates, Inc., and Donna Nestore, Municipal Finance Officer.

The Walnut Street Roadway Improvements project (Base Bid with an Alternate Bid) consists of the milling of existing asphalt roadway, the construction of new asphalt roadway, roadway striping, signage, storm sewer piping, installation of concrete vertical curb, driveway aprons, and topsoil/hydro-seeding.

Seven (7) prospective bidders and one (1) project lead source company obtained bid documents for this project, from which the Borough received five (5) bid proposals. The apparent low bidder is GWP Enterprises, Inc. of Franklinville, New Jersey. The bid offered is in the amount of \$157,175.00 for the Base Bid, and in the amount of \$11,940.00 for Alternate No. 1 Bid, for a total bid in the amount of \$169,115.00. The NJDOT allotment for this project is \$270,000.00.

We have reviewed the low bid offered and believe it to be in order. As noted previously, the NJDOT allotment for this project is \$270,000.00. **As such, we recommend the award of the bid to GWP Enterprises in an amount not to exceed \$157,175.00 for the Base Bid, \$11,940.00 for Alternate No. 1 Bid, for a total bid of \$169,115.00.** This recommendation is subject to the review of the Borough Solicitor and verification of funds by the Municipal Finance Officer.

We respectfully request that this item be placed on the agenda for review and approval at the next available Mayor and Council meeting. It should be noted that the original bid documents were left with you after the bid opening for the Borough's records. By copy of this letter, we have forwarded copies of the bid forms and related documents to Timothy Scaffidi, Esquire, Borough Solicitor for his review and comment. Subject to the award of the bid, the bid bonds can be returned to the respective bidders.

It should also be noted that upon the Borough's recommendation to award, three (3) original copies of the Resolution of Award should be sent to this office for submission to the Division of Local Aid and the Economic Development District Office for approval of the Department of Transportation.
