**BOROUGH OF CLAYTON
AUTHORIZING CONTRACT FOR BITUMINOUS MATERIALS**

WHEREAS, pursuant to cooperative pricing authority vested in the County of Gloucester, State of New Jersey, under Cooperative Pricing, the County of Gloucester has solicited bids for the furnishing of Bituminous Material and Patch and awarded Master Contract PD 019-015, which solicitation for bids and Master Contract establishes specifications for furnishing Bituminous Materials and Patch to the County of Gloucester and to participating Municipalities in the County of Gloucester; and

WHEREAS, said Master Contract provides for the furnishing of Bituminous Materials and Patch to the Borough of Clayton enters into a separate contract with the Contractors for said purpose; and

WHEREAS, the Borough of Clayton has determined to enter into a separate contract to the aforementioned Master Contract, in accordance with the provisions of law and N.J.S.A. 5:30-17.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that the Borough of Clayton shall enter into a contract with South State Inc. for the furnishing of Bituminous Materials for the period of May 4, 2020 to May 4, 2022 in accordance with bid prices as set forth in the contract between the supplier and the Borough, and more particularly described in the contract attached hereto and made a part hereof.

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized to execute said contract on behalf of the Borough.
