

RESOLUTION 109-21

RESOLUTION AUTHORIZING THE PURCHASE OF SEVENTY-FIVE (75) 64-GALLON AND TWENTY-FIVE (25) 96-GALLON RECYCLING CARTS AS PART OF SOURCEWELL (PREVIOUSLY NJPA) UNDER A NATIONAL COOPERATION PURCHASE PROGRAM BY THE BOROUGH OF CLAYTON

WHEREAS, N.J.S.A. 52-34-6.2(b)(3) authorizes contracting units to purchase goods, or to contract for services, may make purchases and contract for services through the use of a nationally-recognized and accepted cooperative purchase agreement that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the Borough of Clayton had authorized by Resolution Membership in the Sourcewell (previously NJPA) Cooperative Purchasing Program effective July 9, 2020; and

WHEREAS, Sourcewell (previously NJPA) is a nationally recognized and accepted cooperative purchasing contracting unit within the State of Minnesota that utilizes a competitive bid or competitive proposal process in awarding contracts for goods and services and is authorized by Minnesota law to extend its contracts to local government units nationwide; and

WHEREAS, the Interlocal Contract for Cooperative Purchasing runs from August 18, 2017 through August 18, 2021; and


WHEREAS, the Borough of Clayton proposes to purchase Seventy-five (75) 64-Gallon and Twenty-five (25) 96-Gallon Recycling Carts under the Sourcewell (previously NJPA) Cooperative Purchase Program, Contract #041217-WQI for the Borough of Clayton.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

1. That the governing body does hereby approve the purchase of Seventy-five (75) 64-Gallon and Twenty-five (25) 96-Gallon Recycling Carts through the Sourcewell (previously NJPA) Cooperative Purchasing Program, Contract # 041217-WQI in the total amount of \$6,396.35.
2. Donna Nestore, CFO for the Borough of Clayton certifies the above referenced dollar amount is available through the 2019 and 2020 Recycling Tonnage Grants, for the purchase of Seventy-five (75) 64-Gallon and Twenty-five (25) 96-Gallon Recycling Carts through the Sourcewell (previously NJPA) Cooperative Purchasing Program, Contract # 041217-WQI for the Borough of Clayton.
