**RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF FIRE
HYDRANTS IN THE BOROUGH OF CLAYTON

NOW, THEREFORE, BE RESOLVED, by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey that the said Caterina Supply Inc. of Williamstown, New Jersey, be and hereby is awarded the contract for the purchase of fire hydrants as tabulated in the Summary of Bids attached hereto and made a part hereof, in accordance with and pursuant to the specifications promulgated by the Borough of Clayton.

BE IT FURTHER RESOLVED that before any purchase can be made pursuant to the within award, a certification must be obtained from the Borough Chief Financial Officer certifying that sufficient funds are available at that time for that particular purchase and identifying the line item of the Borough of Clayton Water & Sewer Department Budget out of which said funds will be paid.
