

## **RESOLUTION 138-21**

### **RESOLUTION AWARDING CONTRACT FOR UNIT PRICE BID VARIOUS WATER MAIN COMPONENTS AND QUANTITIES IN THE BOROUGH OF CLAYTON (CORE & MAIN LP)**

**WHEREAS**, pursuant to due notice and advertisement as required by law, the Borough of Clayton received sealed bids on June 30, 2021 for Various Water Main Components and Quantities; and

**WHEREAS**, Core & Main LP. of Berlin, New Jersey was the successful low bidder as to the items set forth below:

Categories 8-9, 12-15, 17, 27, 42-45

**WHEREAS**, the specifications and bids were for unit prices only, thereby resulting in “open-ended contract” which make it impossible to determine the exact amount of funds which will be expended pursuant thereto, thereby requiring no certification of availability of funds at this time.

**NOW, THEREFORE, BE RESOLVED**, by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey that the said Core & Main LP. of Berlin, New Jersey, be and hereby is awarded the contract for the items as set forth above, for the unit bid prices submitted by said bidder for said items, as tabulated in the Summary of Bids attached hereto and made a part hereof, in accordance with and pursuant to the specifications promulgated by the Borough of Clayton.

**BE IT FURTHER RESOLVED** that before any purchase can be made pursuant to the within award, a certification must be obtained from the Borough Chief Financial Officer certifying that sufficient funds are available at that time for that particular purchase and identifying the line item of the Borough of Clayton Water & Sewer Department Budget out of which said funds will be paid.
