

**RESOLUTION 139-21**

**RESOLUTION AWARDING CONTRACT FOR UNIT PRICE BID VARIOUS WATER  
MAIN COMPONENTS AND QUANTITIES IN THE BOROUGH OF CLAYTON  
(FERGUSON ENTERPRISE LLC)**

**WHEREAS**, pursuant to due notice and advertisement as required by law, the Borough of Clayton received sealed bids on June 30, 2021 for Various Water Main Components and Quantities; and

**WHEREAS**, Ferguson Enterprise LLC, of Lakewood, New Jersey was the successful low bidder as to the items set forth below:

**BE IT FURTHER RESOLVED** that before any purchase can be made pursuant to the within award, a certification must be obtained from the Borough Chief Financial Officer certifying that sufficient funds are available at that time for that particular purchase and identifying the line item of the Borough of Clayton Water & Sewer Department Budget out of which said funds will be paid.
