

**RESOLUTION: 195-21**

**RESOLUTION AUTHORIZING AGREEMENT FOR CERTAIN  
PROFESSIONAL SERVICES ADOPTED BY THE BOROUGH OF  
CLAYTON**

***WHEREAS***, there exists a need for specialized services on behalf of the Borough of Clayton; and

***WHEREAS***, funds are or will be available for this purpose; and

***WHEREAS***, the Local Public Contracts Law, N.J.S.A. 40A:11-1 requires that notice with respect to contracts for Professional Services awarded without competitive bids must be publicly advertised.

***NOW, THEREFORE, BE IT RESOLVED*** by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

1. That ERI, Inc., of Mount Laurel, New Jersey is hereby hired to provide environmental engineering services for Bid Specification Preparation for soil disposal for former Wayne's Auto for the Borough of Clayton in an amount not to exceed \$4,600.00.
2. The term of this contract shall be from September 23, 2021 to September 22, 2022.
3. Donna Nestore, CFO, for the Borough of Clayton certifies that \$4,600.00 is available through Ordinance 17-2015.
3. The Contract is awarded without competitive bidding as a "Professional Service" in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-11-5(1)(a), and the Fair and Open Process because it is for services performed by persons authorized by law to practice a recognized profession.
4. A copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Clayton.
5. A notice in accordance with the Local Public Contracts Law of New Jersey shall be published in The Sentinel or Gloucester County Times.

6. The Mayor and Clerk of the Borough of Clayton are hereby authorized to execute a Contract outlining the above on behalf of the Borough of Clayton.

The additional soil sampling was required as part of the ongoing soil remediation for lead at the site. At this juncture, all soil has been excavated.

**Task 1: Additional time and expense for post excavation soil sampling**

ERI has conducted additional excavation oversight and soil sampling at the Former Wayne's Auto to confirm the removal of residual lead impacted soil. Soil samples were submitted for laboratory analysis.

ERI has conducted this task for a fee of **\$3,600.00**

**Task 2: Pre-classification Soil Sampling**

ERI will conduct pre-classification soil sampling at the site, in advance of contractors sampling requirements. Note that soil disposal facilities have different analytical requirements and frequency based on volume. This task will include analytical information that will be common for all disposal facilities.

ERI will conduct this task for a fee of **\$1,000.00**

**Total for this scope and fee proposal** **\$4,600.00**

No other activities will be included in this proposal. All terms and conditions of ERI's contractual agreement with the Borough of Clayton are in effect.
