**ADDENDUM #1 TO SHARED SERVICES AGREEMENT FOR FINANCIAL
CONTRIBUTION TOWARDS THE COST TO PROVIDE UP TO TWO (2) CLASS III
SCHOOL RESOURCE OFFICERS TO THE CLAYTON SCHOOL DISTRICT
BETWEEN THE BOROUGH OF CLAYTON AND THE CLAYTON BOARD OF
EDUCATION**

WHEREAS, this ADDENDUM #1 dated 12/9/2021 is related to a Shared Services Agreement dated March 28, 2019 between the Borough of Clayton and the Clayton Board of Education for financial contribution towards the cost to provide up to two (2) Class III School Resource Officers to the Clayton Board of Education; and

WHEREAS, the Parties have agreed to amend the existing Shared Services Agreement and have agreed to certain terms as stated below to the original Shared Services Agreement.

NOW, THEREFORE, BE IT RESOLVED THAT the Borough of Clayton and the Clayton Board of Education agree as follows:

TERMS

1. The hourly rate of pay for a School Resource Officer shall increase from \$33.00 per hour to \$35.00 per hour.
2. The monthly financial payment to the Borough of Clayton from the Clayton Board of Education will increase to \$2,604.00 beginning January 1, 2022.
3. The total amount payable to the Borough of Clayton from the Clayton Board of Education from September 2021 through December 2021 will be \$9,820.80.
4. The total amount payable to the Borough of Clayton from the Clayton Board of Education for January 2022 to June 2022 will be \$15,624.00.
5. The total amount payable to the Borough of Clayton from the Clayton Board of Education starting September 2022 through June 2023 will be \$26,040.00.

BE IT FURTHER RESOLVED that all other terms and conditions of the Shared Services Agreement between the parties dated March 28, 2019 shall remain in full force and effect unless otherwise modified by this Addendum #1.


THE PARTIES, by signing this Addendum #1, agree to the terms as set forth above.
