Environmental Resolutions Inc. (ERI) is pleased to provide this scope and fee proposal to the Borough of Clayton (Borough) for the continuation of environmental activities associated with the Clayton Water Yard. This proposal provides continuation of ground water monitoring and sampling for <u>first quarter 2021 only</u> Additional activities will be conducted under separate scope and fee proposal. ERI will conduct the following scope of services:

1. Ground Water Monitoring and Sampling (January 2021)-MW8 and MW9

ERI will retain the services of a New Jersey Certified Laboratory to conduct ground water monitoring and sampling for ground water monitoring wells MW8 and MW 9 (well that has previously shown contamination). These wells correspond to the wells that were part of the Classification Exception Area provided in the December 2019 Remedial Investigation Report prepared and submitted to the New Jersey Department of Environmental Protection.

Ground water samples will be analyzed for constituents associated with gasoline contamination only, plus Tentatively Identified Compounds, which have been identified in previous ground water samples, with field blanks and trip blanks. The lab results will be available approximately two (2) weeks after the samples are collected and submitted to the laboratory.

In addition to collecting samples for lab analysis, the certified lab will monitor each well for field parameters including pH, dissolved oxygen, temperature and specific conductivity as well as ground water elevations from each well. For purposes of this proposal, only one (1) round of ground water sampling have been proposed.
