RESOLUTION AUTHORIZING AGREEMENT FOR CERTAIN PROFESSIONAL SERVICES ADOPTED BY THE BOROUGH OF CLAYTON

WHEREAS, there exists a need for specialized services on behalf of the Borough of Clayton; and

- 6. A notice in accordance with the Local Public Contracts Law of New Jersey shall be published in <u>The Sentinel or South Jersey Times</u>.

Environmental Resolutions Inc. (ERI) is pleased to provide the Borough of Clayton with this scope of services proposal for the remediation of lead contaminated soil at the above referenced site. Per our discussion of March 19, 2021, the Borough of Clayton Public Works Department, under ERI's direction, will excavate the top two (2) feet of lead contaminated soil, and stage it onsite for transportation and disposal by an approved transporter, to an approved facility. ERI will conduct the following scope of services.

1. Request For Proposal from Qualified Contractors for Transportation and Disposal of Historically Applied Pesticide Contaminated Soil With and Without Backfilling with Certified Cleanfill

ERI will prepare specifications for the transportation and disposal of Historically Applied Pesticide contaminated soil. ERI will solicit quotations from at least three (3) qualified contractors to transport Historically Applied Pesticide contaminated soil to an approved facility. Items to be included will be line item cost for disposal analysis by an approved facility, to be reviewed and approved by ERI prior to transportation and disposal; transportation and disposal of an estimated 120 tons of Historically Applied Pesticide contaminated soil and backfill with certified cleanfill. ERI will also prepare the Request For Proposal to include a separate line item for disposal only, without certified cleanfill.

Also included shall be a review of the quotations submitted and the recommendation of contract award to the lowest qualified bidder. No site walk will be conducted. ERI assumes the Borough will be a repository for questions from bidders, which will be provided to ERI to provide responses.

Estimated Fee Not To Exceed \$500.00

Note: Contractor will be retained directly by the Borough.

2. Excavation oversight and sampling

ERI will have one (1) field technician onsite to oversee the excavation and of the lead impacted soil by the Borough of Clayton Public Works Department Soil samples will be collected around the perimeter and base of the excavation and will be submitted to a New Jersey certified laboratory for Historically Applied Pesticides. All soil samples will be submitted for standard (2 week) turnaround. ERI assumes the Borough of Clayton Public Works Department will place plastic sheeting at the base of the excavation after completion. When certified backfill is brought in by the contractor, ERI assumes the Borough of Clayton Public Works will backfill the area with clean fill. ERI assumes excavation/sampling activities will be conducted in one (1) business day.
