RESOLUTION AUTHORIZING SALE OF ONE (1) 2009 INT KME PUMPER TRUCK TO GREENWICH TOWNSHIP, CUMBERLAND COUNTY BY THE BOROUGH OF CLAYTON

WHEREAS, the governing body of the Borough of Clayton has agreed to sell the "Pumper Truck" to Greenwich Township, Cumberland County for said amount.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

- That the governing body does hereby approve and authorize the sale of the 2009
 INT KME pumper truck to Greenwich Township, Cumberland County, for the total sum of \$140,000.00 in its "AS IS" condition.
- That the Mayor be and is hereby authorized to execute a Bill of Sale transferring ownership of the 2009 INT KME pumper truck to Greenwich Township, Cumberland County upon payment of the purchase price.
