RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) INTERNATIONAL CV515, 4-5 YARD DUMP TRUCK AS PART OF SOURCEWELL UNDER A NATIONAL COOPERATION PURCHASE PROGRAM BY THE BOROUGH OF CLAYTON

WHEREAS, N.J.S.A. 52-34-6.2(b)(3) authorizes contracting units to purchase goods, or to contract for services, may make purchases and contract for services through the use of a nationally-recognized and accepted cooperative purchase agreement that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the Borough of Clayton had authorized by Resolution Membership in the Sourcewell Cooperative Purchasing Program effective July 9, 2020; and

WHEREAS, Sourcewell is a nationally recognized and accepted cooperative purchasing contracting unit within the State of Minnesota that utilizes a competitive bid or competitive proposal process in awarding contracts for goods and services and is authorized by Minnesota law to extend its contracts to local government units nationwide; and

WHEREAS, the Borough of Clayton proposes to purchase one (1) International CV515, 4-5 Yard Dump Truck under the Sourcewell Cooperative Purchase Program, for the Clayton Public Works Department. The Sourcewell Contract #060920-NVS awarded to Hunter Truck Sales and Service (authorized dealer for International) runs from August 5, 2020 through August 1, 2024.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

- 1. That the governing body does hereby approve the purchase of one (1) International CV515, 4-5 Yard Dump Truck through the Sourcewell Cooperative Purchasing Program, Contract #060920-NVS in the total amount of \$132,428.35
- 2. Donna Nestore, CFO for the Borough of Clayton certifies the above referenced dollar amount is available through Ordinance 13-2022 for the purchase of one (1) International CV515, 4-5 Yard Dump Truck under the Sourcewell Cooperative Purchasing Program, Contract #060920-NVS for the Clayton Public Works Department.
