**RESOLUTION AUTHORIZING ONE YEAR RENEWAL OF AGREEMENT

WHEREAS, the Borough of Clayton has entered into a multi-year option Agreement for Solid Waste and Recycling Collection Service with Gold Medal Environmental; and

WHEREAS, the Borough of Clayton is required to notify Gold Medal Environmental if the Borough intends on renewing the contract for any additional one year extension; and

WHEREAS, the Borough is in agreement to renew the Contract again for one additional year effective January 1, 2023 to December 31, 2023 pursuant to the terms and conditions in said Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

1. That the governing body does hereby again approve the renewal of the Agreement between the Borough of Clayton and Gold Medal Environmental for one additional year effective January 1, 2023 through December 31, 2023 pursuant to the terms and conditions in said Agreement

2. That the Mayor or Borough Administrator be and is hereby authorized to notify Gold Medal Environmental in writing of said renewal on behalf of the Borough of Clayton along with a copy of this Resolution.
