RESOLUTION AUTHORIZING THE EXECUTION OF AN APPLICATION TO THE NEW JERSEY DEPARTMENT OF TRANSPORTATION - BICYCLE AND PEDESTRIAN PLANNING ASSISTANCE PROGRAM, FOR REVITALIZATION IN THE BOROUGH OF CLAYTON.

**WHEREAS**, the New Jersey Department of Transportation has taken steps to establish and pursue a vision for safe transportation and recreation systems through the adoption of the Complete Streets policy.

**WHEREAS**, the New Jersey Department of Transportation has committed to the planning, design, construction, maintenance, and operation of the facilities that provide these services; and

WHEREAS, the New Jersey Department of Transportation has available funding for the Bicycle and Pedestrian Planning Assistance Program (BPPA) which is available to municipalities that demonstrate a strong need for improved accommodations for pedestrian, bicycle, and motorist travel; and

**WHEREAS**, the Borough of Clayton identifies a need for said funding to conduct infrastructure and streetscape improvements that address existing transportation safety concerns in the downtown; and

**WHEREAS**, the Borough of Clayton desires to enhance the economic viability of the downtown by attracting new businesses to the area through infrastructure revitalization.

**NOW, THEREFORE, BE IT RESOLVED**, that the Council of the Borough of Clayton will apply for a NJDOT Bicycle and Pedestrian Planning Assistance Program Grant to conduct planning activities that will result in infrastructure improvements. The requested amount will not exceed \$100,000; and

**BE IT FURTHER RESOLVED**, that the Council, commits in good faith, to make a good effort to implement the recommendations of the planning effort; and

**BE IT FURTHER RESOLVED**, that the Council, commits in good faith, to pursue the creation and adoption of a Complete Streets Policy that prioritizes safe transportation and recreation systems.
