WHEREAS, the Borough advertised for public bids for a 2020 or Newer Utility/Brush Truck; and

WHEREAS, one (1) sealed bid from Kyrish Government Group for a 2020 or Newer Utility/Brush Truck was received and opened on October 25, 2022; and

WHEREAS, on October 26, 2022, the Borough Solicitor reviewed the bid submission and submitted a letter to the Borough of Clayton noting the following discrepancies:

- Stockholder Disclosure Certification was not completed as to the stockholders
 of the LLC nor was the document signed and notarized.
- 2. Non-Collusion Affidavit was not submitted with Bid.
- 3. Bidder Information Statement. In Section A, the line for State of Corporation has "expired" but in Section B indicates corporation is registered in Texas.

WHEREAS, N.J.S.A. 40A:11-13 et al. outlines the reasons why a contracting unit may reject bids received; and

WHEREAS, the Borough desires to reject the bid received and opened on October 25, 2022 from Kyrish Government Group for failure to meet the mandatory bid requirement pursuant to N.J.S.A. 40A:11-23.2(e).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey as follows:

1. That the bid received from Kyrish Government Group for 2020 or Newer Utility/Brush Truck for the Borough of Clayton be and is hereby rejected for the reasons as stated above.
