- Your agency must complete and return the enforcement summary report with the total statistics for the mobilization from your agency.
- The following financial paperwork must be submitted: Expenditure summary, salary detail form, payment voucher, and payroll certification. These forms must be signed by your CFO/Treasurer.

The Enforcement Summary Report is due by January 9, 2023. All remaining paperwork must be submitted no later than January 23, 2023. <u>Failure to submit the required paperwork on time may result in non-reimbursement of your overtime</u>. All necessary paperwork is attached. Please disregard all previous forms and use the ones that are attached. They have been updated.
