APPOINTING PS & S AS ARCHITECT FOR THE BOROUGH OF CLAYTON FOR THE YEAR 2024, PURSUANT TO THE LOCAL PUBLIC CONTRACTS LAW

WHEREAS, there exists a need for an Architect in the Borough of Clayton for the purpose of providing the Borough with architectural services and advice; and

WHEREAS, funds are or will be available for this purpose; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires the governing body of a contracting unit to public a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for "professional services" without competitive bidding;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton as follows:

- That PS & S be hereby appointed as Architect for the Borough of
 Clayton, to provide services and advice to the officials of said Borough for the year 2024.
- 2. The term of this contract shall be from January 1, 2024 to December 31, 2024, in an amount not to exceed \$50,000.00.
- 3. Donna Nestore, CFO, for the Borough of Clayton certifies the above referenced dollar amount is available through the 2024 budget. The maximum dollar value is based on a reasonable estimate of the goods or services required over the contract term, and the Borough of Clayton is not obligated to spend that amount.
- 4. That the appropriate officers of the Borough of Clayton are hereby authorized to enter into the contract with PS & S, for architectural services above specified, for a term of one (1) year, commencing January 1, 2024 and to be paid in accordance with the 2024

budget.

annexed contract are on file and available for public inspection in the Office of the Clerk of the

Borough of Clayton.
