## RESOLUTION OF THE BOROUGH OF CLAYTON, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY REFERRING CERTAIN MATTERS TO THE CLAYTON PLANNING BOARD FOR REVIEW AND RECOMMENDATIONS PURSUANT TO N.J.S.A. 40:55D-26

WHEREAS, the Borough of Clayton is a municipal entity organized under the laws of the State of New Jersey and located in Gloucester County, New Jersey ("Clayton"); and

**WHEREAS**, the Clayton Planning Board ("Planning Board') is an autonomous entity created by the Borough of Clayton pursuant to and governed by N.J.S.A. 40:55D-1 et seq.; and

WHEREAS, the statute, N.J.S.A. 40:55D-26(a) requires that, prior to the adoption of a development regulation, revision, or amendment thereto, the Clayton Planning Board shall make and transmit to the governing body, within 35 days after referral, a report including identification of any provisions in the proposed development regulation, revision or amendment which are inconsistent with the master plan and recommendations concerning these inconsistencies and any other matters as the board deems appropriate; and

**WHEREAS**, the Mayor and Borough Council of the Borough of Clayton wish to refer to the Clayton Planning Board, pursuant to N.J.S.A. 40:55D-26(a), the following issue for discussion as to enactment of an appropriate ordinance addressing the item:

Amending Chapter 88, Storm Water Control, Article XII, Repealing Sections 88-95 to 88-105.3 and Adopting New Sections 88-95 to 88-104 of the Code Book of the Borough of Clayton.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Clayton, that pursuant to N.J.S.A. 40:55D-26(a), the issue of the amendments to the Ordinance to amend Chapter 88, Stormwater Control, Article XII, within the Borough of Clayton, be and hereby is referred to the Clayton Planning Board for the action as required by statute.
