RESOLUTION AUTHORIZING AWARDING OF CONTRACT FOR WATER METERS IN THE BOROUGH OF CLAYTON (RIO SUPPLY INC.)

BE IT FURTHER RESOLVED that before any purchase can be made pursuant to the within award, a certification must be obtained from the Borough Chief Financial Officer certifying that sufficient funds are available at that time for that particular purchase and identifying the line item of the Borough of Clayton Water & Sewer Budget out of which said funds will be paid.
